Photography, Video, Voice Recording, and Publicity Release Agreement

This Photography, Video, Voice Recording, and Publicity Release Agreement ("Agreement") is entered into by the undersigned participant ("Participant") in connection with the Miss Monterey Park Pageant and Teen Pageant and any related Monterey Park Chamber of Commerce activities, promotions, and events.

1. Consent to Collection and Use

Participant hereby grants permission to the Monterey Park Chamber of Commerce, and its officers, directors, employees, agents, contractors, sponsors, affiliates, licensees, assigns, and any person or entity authorized by the Chamber (collectively, "Chamber"), to photograph, record, film, audiotape, and otherwise capture Participant's image, likeness, voice, name, appearance, performance, statements, and other recordings or depictions, whether still or moving, written or spoken, in connection with the Pageant and Chamber activities. Participant understands and agrees that all such photographs, videos, audio recordings, voice recordings, images, likenesses, and related materials, together with any excerpts, edits, reproductions, adaptations, derivatives, and composites thereof, shall be the sole and exclusive property of the Monterey Park Chamber of Commerce.

2. Permission for Broad Use

Participant authorizes the Chamber to use, reproduce, publish, distribute, display, broadcast, edit, alter, adapt, license, and otherwise exploit the materials described above, in whole or in part, in any manner and in any medium now known or later developed, including without limitation:

- print media;
- advertisements;
- marketing materials;
- television commercials;
- television programs;
- social media;
- websites;
- digital and online platforms;
- promotional campaigns;
- public relations materials;
- event publicity;
- fundraising materials; and
- all other forms of advertising or promotion, whether local, regional, national, or global.

Participant acknowledges that the Chamber may use these materials in any manner determined by the Chamber, in its sole discretion, for Miss Monterey Park Pageant, Teen Pageant, and broader Chamber promotional purposes.

3. No Compensation

Participant understands and agrees that no compensation, payment, royalty, or other remuneration of any kind will be provided for the capture, use, publication, broadcast, or other exploitation of the materials described in this Agreement.

4. Release of Claims

To the fullest extent permitted by law, Participant releases and forever discharges the Monterey Park Chamber of Commerce and its officers, directors, employees, agents, contractors, sponsors, affiliates, licensees, assigns, and authorized users from any and all claims, demands, causes of action, damages, liabilities, and expenses of any kind arising out of or relating to the capture, use, reproduction, publication, broadcast, display, or distribution of the materials described in this Agreement, including without limitation claims for invasion of privacy, misappropriation, right of publicity, defamation, false light, or any similar claim.

5. Waiver of Approval Rights

Participant waives any right to inspect or approve the finished materials, the context in which they are used, or any accompanying text, audio, visual, or other content used in connection with them.

6. Minor Participant

If Participant is under 18 years of age, the signature of a parent or legal guardian is required. The undersigned parent or legal guardian represents and warrants that they are authorized to execute this Agreement on behalf of the minor Participant and consent to all terms of this Agreement for the minor Participant's benefit.

7. Understanding and Voluntary Execution

Participant represents that they have read and understood this Agreement, voluntarily agree to its terms, and have had the opportunity to ask questions before signing.
